

## MEXICAN YEARBOOK OF INTERNATIONAL LAW

### INSTRUCTIONS FOR CONTRIBUTORS

#### *Editorial Policy*

The *Mexican Yearbook of International Law* is one of the most relevant Latin American publications in the field. Its contents refer to research articles, comments, as well as international and Mexican practice issues. The MYIL is an essential reading for academics and practitioners who need to stay abreast of recent developments worldwide. Therefore, only articles which fall within the scope of the International Law will be considered for publication.

#### *Submissions*

Only original and unpublished contributions will be accepted. The Yearbook's official language is Spanish. Contributions written in French and English will be published in those languages. Articles that have been published in the aforesaid languages or other will be considered only if it is the first time that they are translated to Spanish.

The Institute of Legal Research is in charge of the publication of this MYIL. It provides "Editorial Criteria" to which every contribution shall meet. These parameters are available online in Spanish only, in the website of the Institute, <http://www.juridicas.unam.mx> (Section of "Publications", "Criterios Editoriales").

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. Upon acceptance

of a paper, the authors will be asked to assign copyright to the Institute of Legal Research.

Contributions are accepted until the second week of July.

### *Manuscript Preparation*

The editors recommend the following requirements for the manuscript: 1.5 spaced, Font Arial 12. A diskette or an e-mail file must also be sent along with the article in Word for Windows 6 or 7. The maximum length of each contribution is: 35 pages for articles; 25 pages for comments; and 10 pages for book reviews.

Each contribution must have an abstract of no more than 200 words in Spanish, English and French (if necessary, the Institute will do the corresponding translations).

Every contribution must include a separate sheet with the author's address and email in order to contact him. He/she must indicate the institution to which he belongs, as well as his academic position, and some of his background.

### *Procedure*

After receipt, the contribution will be sent for peer review without revealing the author's name. If the article is eligible for publication, any revisions deemed necessary will be sent to the author. The author will be given two weeks to make the necessary changes. If the result of the revision is negative, the manuscript will not be published.

### *Publication*

The *Mexican Yearbook of International Law* is published in January every year. Each author is sent one volume.

Contributors are responsible for obtaining permission to reproduce any materials, including photographs and illustrations for which they do not hold copyright, and for ensuring that the appropriate acknowledgements are included in the manuscripts.
